### COVERS AND TABS—COLOR ONLY

**Publication Trim Size:** 6⅝" x 9"

**Special Placement:** 15% additional charge

**Technical Requirements:** PDF is the preferred format for all ads, with the following guidelines:

- Ads must be in final print size.
- Fonts must be embedded in file.
- File must be saved using the "Press Optimized" setting.
- Resolution must be at least 300 ppi.
- Colors must be CMYK.

We strongly recommend that you check your ad for press readiness by using pre-flight software. Ads smaller than 2MB can be e-mailed to [nperrott@rhscommunications.com](mailto:nperrott@rhscommunications.com), but larger ads should be submitted on CD or DVD to the address below.
